# CORE CURRICULUM & COURSE DESCRIPTIONS

## **LIVING AN AUTHENTIC LIFE WITH PURPOSE**

Wealth can offer a paralyzing number of choices regarding what to do with your life. Considering your family's legacy, your own interests, and what you bring to the table can give rise to the challenge of how to make your life meaningful. How do you define work and where does it fit in your world? How do you balance both your career and family engagement? Whether you have previously considered a purpose-driven life or found your purpose shifting in recent years, this module will provide the planning tools necessary to navigate this process thoughtfully and with authenticity.

## **MODERN FAMILIES: INCLUSIVENESS AND SPOUSAL ROLES**

The nuclear family of 2020 does not resemble the nuclear family of the past. This session will challenge you to evaluate your own definition of 'family' with which you live and engage. Explore the stories of wealthy families who confronted issues of inclusion head on. Under what conditions are spouses involved in the affairs of your family? Do domestic, live-in partners get any access to your family office services? Are there smaller roles in your governance structure that could open doors for not only new family members, but new ideas? We will explore how to usher in inclusion where you feel it is most needed in your family.

## **INFLUENCE WITHOUT AUTHORITY**

Be it committee participation or observing board meetings, as a Rising Generation family member, you have an opportunity to influence decisions and discussions. This module will examine ways in which you can offer insights, ask questions, or guide discussions without having formal authority. We will consider frameworks to evaluate what type of participation is called for in different settings, help you determine when and how to exercise your influence as a family member in a larger dialogue, and explore being mindful of the hierarchy within your family's governance structure.

## **MANAGING CHANGE AND DECISION-MAKING IN YOUR FAMILY**

Over time, families grow and change. There are additions of new family members, the passing of leadership from one generation to another, the acquisition or dissolution of new businesses or investments. Change is a constant. Learning how to navigate that change as a family, and to make effective decisions in the face of shifting priorities, is essential for family members. This session will help you analyze your current decision-making model and align your family around the right priorities to make decisions in a timely manner.
